In reference to Schedule "B", page 61 of 82:

Q. Please provide specifics as to the purchases of the passenger/off-road vehicles and the heavy fleet vehicles. Please advise if these vehicles have already been ordered or negotiated. Please advise as to the tendering process that is in place for the purchase of these vehicles. Please advise what screening and evaluation process is undertaken for each and every vehicle before a determination for replacement. Please provide evidence of the maintenance history and the mileage of each and every vehicle to be replaced.

A. To date, no vehicles have been ordered and no formal negotiations with suppliers have taken place.

Vehicle requirements will be communicated to suppliers who are identified as having the capability to supply those requirements, with a view to obtaining bids pursuant to a formal tender call or proposals pursuant to a request for proposals process. If competing suppliers cannot be identified, the required vehicles and equipment will be negotiated with sole source suppliers to ensure they are obtained at the lowest available price.

All units being replaced are evaluated based on factors such as overall condition, maintenance history and immediate repair requirements. As an overall guideline, passenger vehicles are generally replaced when they have reached five years of age or 150,000 kilometres. For heavy vehicles, the guideline is 10 years of age or 250,000 kilometres.

Attachment A is the list of the Passenger and Heavy Fleet vehicles scheduled for replacement in 2003, including each unit's odometer reading as of October 2, 2002 and Life Maintenance Costs. For the Off-Road category of vehicles, odometer readings are not normally applicable or available and the Company does not maintain records of historical maintenance costs.
