The tables below provide a summary of the number of Newfoundland Power's recorded service interruptions for the transmission lines identified in the Rebuild Transmission Lines category of the 2001 Capital Budget (Schedule B, page 31 of 70). The information is provided on an annual basis for the period 1997 to October 2002 inclusive.

As indicated in the original justification for this category, replacement of deficient equipment was to *prevent* service interruptions (emphasis added). Transmission line inspections revealed conditions that, if not corrected, would result in an increase in service interruptions. By rebuilding these lines, the conditions identified by the line inspections were rectified before additional potential problems occurred. This action prevented service interruptions that likely would have resulted had the work not been carried out.
