RE: LIST OF PRESENTERS FOR SEPTEMBER HEARING

We write further to your email of 08 August 2018 outlining the schedule of presenters for the resumption of hearings in September.

You indicate that the Campaign has "additional presenters who have not provided reports". These people have not been identified to us and we have no information on what their presentations will be about. This is a considerable concern to our client given that we are less than one month from resumption of hearings.

We refer to your email of 20 June 2018, wherein you addressed procedural issues and scheduling. At that time, you indicated that the Campaign was filing the three reports, since filed, and no other reports or presentations were expected. Our client and the Consumer Advocate were asked to identify the reports intended to be filed and the issues to be addressed. We complied with that request.

Now we learn over six weeks later that the Campaign has further presenters. We have no information on the number of those presenters, their identities, or the issues they will address. This should have been provided so the parties could properly prepare for the resumption of the hearings. This issue goes to the procedural fairness of the hearing. The identities and issues to be addressed by these "presenters" should be provided forthwith. We ask that the Board address our concerns.
