My husband and I are 2 seniors having 1 vehicle only. We have been insured with Munn for a number of years.

Our insurance policy for the period May 31, 2016 to May 31, 2017 was \$1,346 total; for May 31, 2017 to May 31, 2018 it is \$2,229.85 total!

AN INCREASE OF 44%! This increase is attributed to : 1) an at-fault claim on tailgate of our truck just under 2 months before the 5 year fault-free time period....plus 2) tax our wonderful government decided to add to insurance again.
