AN ORDER OF THE BOARD

1 **IN THE MATTER OF** the *Automobile*
2 *Insurance Act*, RSNL 1990, c. A-22 (the
3 “*Act*”), as amended and regulations
4 thereunder; and

6 **IN THE MATTER OF** an application by
7 Chubb Insurance Company of Canada for
8 approval to implement a revised rating
9 program for its Commercial Vehicles and
10 Interurban Trucks category of automobile
11 insurance.

14 **WHEREAS** on July 17, 2020 Chubb Insurance Company of Canada applied to the Board for
15 approval of a revised rating program under the IAO filing option for its Commercial Vehicles and
16 Interurban Trucks category of automobile insurance; and

18 **WHEREAS** the IAO filing option may be used by insurers to adopt the most recent IAO rating
19 program accepted for use by the Board; and

21 **WHEREAS** the IAO filing option may also be used to introduce deviations to the IAO rating
22 program by insurers that are proposing to adopt or are currently using IAO rates; and
23

24 **WHEREAS** Chubb Insurance Company of Canada proposed to adopt the IAO rates for
25 Commercial Vehicles and Interurban Trucks accepted for use by the Board in Information Bulletin
26 A.I. 2020-06 issued on May 5, 2020; and

28 **WHEREAS** no deviations to the IAO rating program are proposed; and

30 **WHEREAS** Chubb Insurance Company of Canada does not have sufficient company loss
31 experience to prepare an independent actuarially based filing; and

33 **WHEREAS** the revised rating program is consistent with the IAO Filing Guidelines and is
34 supported; and

1 **WHEREAS** the Board is satisfied that the proposed rates are just and reasonable in the
2 circumstances, do not impair the solvency of the insurer, are not excessive in relation to the
3 financial circumstances of the insurer, and do not violate the Automobile Insurance Act or the
4 Insurance Companies Act or the respective regulations thereunder.

7 **IT IS THEREFORE ORDERED THAT:**

9 1. The revised rating program received July 17, 2020 from Chubb Insurance Company of Canada
10 for its Commercial Vehicles and Interurban Trucks category of automobile insurance is
11 approved to be effective no sooner than September 1, 2020 for new business and renewals.
