18	WHEREAS the IAO filing option may be used by insurers to adopt the most recent IAO rating
19	program accepted for use by the Board; and
20	WIIFDEAS Chulch proposed to adopt the IAO rating program for Commercial Vehicles accepted
21 22	WHEREAS Chubb proposed to adopt the IAO rating program for Commercial Vehicles accepted
23	for use by the Board in information bulletin A.I. 2024-03; and
23 24	WHEREAS Chubb has no Commercial Vehicles exposures and thus does not have sufficient
25	volume to justify a rating program based on company specific data; and

27	WHEREAS the proposed rating program results in an overall rate level change of -3.8%; and
28	the proposed ruting program results in an overall rute level change or 5.670, and
