1 **IN THE MATTER OF** the **Petroleum Products Act**,
2 SNL 2001, Chapter P-10.1 and regulations
3 thereunder; and
4

5 **IN THE MATTER OF** the setting of maximum
6 prices to be charged for petroleum products in
7 Zones 10, 11, 11a, 11b, 12 and 14; and
8

9 **IN THE MATTER OF** the lifting of the current
10 suspension of maximum price adjustments for
11 gasoline and diesel motor fuels and stove oil
12 heating fuel in Zones 10, 11, 11a, 11b, 12 and 14;
13 and
14

15 **IN THE MATTER OF** interim changes with respect
16 to zone differentials for gasoline and diesel
17 motor fuels and stove oil heating fuel in Zones
18 10 and 11; and

20 **IN THE MATTER OF** the suspension of maximum
21 price adjustments for gasoline and diesel motor
22 fuels and stove oil heating fuel in Zones 10, 11,
23 11a, 11b, 12 and 14.

26 **WHEREAS** in Order No. P.P. 80(2023) the Board suspended maximum price adjustments for diesel
27 motor fuel and stove oil heating fuel in Zones 10, 11, 11a, 11b, 12 and 14 effective December 21,
28 2023; and

30 **WHEREAS** in Order No. P.P. 28(2024) the Board suspended maximum price adjustments for
31 gasoline motor fuel in Zones 10, 11, 11a, 11b, 12 and 14 effective June 27, 2024; and

33 **WHEREAS** based on delivery information provided to the Board by suppliers to the region,
34 resupply of gasoline and diesel motor fuels and stove oil heating fuel to Zones 10, 11, 11a, 11b,
35 12 and 14 has occurred; and

1 **WHEREAS** the Board is satisfied that it is reasonable to lift the suspension of maximum price
 2 adjustments for gasoline and diesel motor fuels and stove oil heating fuel in Zones 10, 11, 11a,
 3 11b, 12 and 14 to allow for the implementation of new benchmark prices effective December 19,
 4 2024; and

5
 6 **WHEREAS** in November 2024 there were changes to supply dynamics in Zones 10 and 11; and

7
 8 **WHEREAS** the Board obtained further information with respect to the costs of supply under the
 9 new supply dynamics for Zones 10 and 11; and

10
 11 **WHEREAS** based on the information provided, the Board is satisfied that the zone differentials
 12 for gasoline and diesel motor fuels and stove oil heating fuel in Zones 10, 11 and 11b should be
 13 adjusted on an interim basis for the upcoming winter season; and

14
 15 **WHEREAS** based on delivery information provided the Board is satisfied that a suspension of
 16 maximum price adjustments for gasoline and diesel motor fuels and stove oil heating fuel in
 17 Zones 10, 11, 11a, 11b, 12 and 14 should be implemented effective December 19, 2024 until
 18 further order of the Board.



 21 **IT IS THEREFORE ORDERED THAT:**

- 22
 23 1. The suspension of maximum price adjustments for diesel motor fuel and stove oil heating
 24 fuel in Zones 10, 11, 11a, 11b, 12 and 14 implemented pursuant to Order No. P.P. 80(2023) is
 25 lifted, effective December 19, 2024.
 26
 27 2. The suspension of maximum price adjustments for gasoline motor fuel in Zones 10, 11, 11a,
 28 11b, 12 and 14 implemented pursuant to Order No. P.P. 28(2024) is lifted, effective December
 29 19, 2024.
 30
 31 3. The maximum prices in Zones 10, 11, 11a, 11b, 12 and 14 will be adjusted on an interim basis
 32 effective December 19, 2024 to reflect the new cost of resupply, until further order of the
 33 Board.

 35 4. For Zones 10, 11 and 11b the maximum wholesale prices will be adjusted on an interim basis
 36 effective December 19, 2024, with corresponding changes in maximum retail prices, to reflect
 37 the following interim changes in zone differentials, until further order of the Board:


Interim Zone Differential Changes (cents per litre)			
Zone	Gasoline	Diesel	Stove Oil
Zone 10	(6.0)	n/a	n/a
Zone 11	(9.35)	(4.74)	(0.7)
Zone 11b	(9.35)	(4.74)	(0.7)

- 1 5. Maximum price adjustments for gasoline and diesel motor fuels and stove oil heating fuel in
- 2 Zones 10, 11, 11a, 11b, 12 and 14 shall be suspended as of the scheduled maximum price
- 3 adjustment effective December 19, 2024, until further order of the Board.
