1 **IN THE MATTER OF** the **Petroleum Products Act**,

6 prices to be charged for petroleum products
7 in Zones 10, 11, 11a, 11c, 12 and 14; and

10 suspension of maximum price adjustments
11 for gasoline and diesel motor fuels and stove
12 oil heating fuel in Zones 10, 11, 11a, 11c, 12
13 and 14; and

15 **IN THE MATTER OF** the suspension of maximum
16 price adjustments for gasoline and diesel motor
17 fuels and stove oil heating fuel in Zones 10, 11,
18 11a, 11c, 12 and 14.

21 **WHEREAS** in Order No. P.P. 36(2025) the Board suspended maximum price adjustments for
22 gasoline and diesel motor fuels and stove oil heating fuel in Zones 10, 11, 11a, 11c, 12 and 14
23 effective April 18, 2025; and

25 **WHEREAS** based on delivery information provided to the Board by suppliers to the region,
26 resupply of gasoline and diesel motor fuels and stove oil heating fuel to Zones 10, 11, 11a, 11c,
27 12 and 14 has occurred or will be occurring in the coming days; and

29 **WHEREAS** the Board is satisfied that it is reasonable to lift the suspension of maximum price
30 adjustments for gasoline and diesel motor fuels and stove oil heating fuel in Zones 10, 11, 11a,
31 11c, 12 and 14 to allow for the implementation of new benchmark prices effective June 13, 2025;

1 **WHEREAS** based on delivery information provided the Board is satisfied that a suspension of
2 maximum price adjustments for gasoline and diesel motor fuels and stove oil heating fuel in
3 Zones 10, 11, 11a, 11c, 12 and 14 should be implemented effective June 13, 2025 until further
4 order of the Board.



7 **IT IS THEREFORE ORDERED THAT:**

- 9 1. The suspension of maximum price adjustments for diesel motor fuel and stove oil heating
10 fuel in Zones 10, 11, 11a, 11c, 12 and 14 implemented pursuant to Order No. P.P. 36(2025) is
11 lifted, effective June 13, 2025.

- 13 2. The maximum prices in Zones 10, 11, 11a, 11c, 12 and 14 will be adjusted effective June 13,
14 2025 to reflect the new cost of resupply, until further order of the Board.

- 16 3. Maximum price adjustments for gasoline and diesel motor fuels and stove oil heating fuel in
17 Zones 10, 11, 11a, 11c, 12 and 14 shall be suspended as of the scheduled maximum price
18 adjustment effective June 13, 2025, until further order of the Board.
