Following is Newfoundland and Labrador Hydro's (Hydro) reply with regard to the above noted Application.

1.0 Application Background

On May 18, 2018, Hydro filed an Application with the Board for an Order under the Rules of Procedure set for the 2017 General Rate Application whereby information contained in Table 2 of Hydro's response to PUB-NLH-149 is considered to be confidential and that the Intervenor's access to the confidential information is governed by the terms of the undertakings to be executed by the Intervenor's representatives prior to their receipt of that confidential information.

2.0 Procedure

On May 24, 2018, the Board set a schedule with respect to this Application. Requests for Information from the Intervenors were due on May 29, 2018, with Hydro to file responses by June 4, 2018. Upon completion of the RFI process, Intervenors were scheduled to submit comments by June 7, 2018.

3.0 Hydro's Response

Correspondence was received by both Newfoundland Power and the Industrial Customers on June 7, 2018. Hydro notes that the Parties did not have any comments in relation to this Application.

Hydro submits that the Board approve that the information contained in Table 2 of its response to PUB-NLH-149 is considered to be confidential and that the Intervenor's access to the
