**Re: Newfoundland and Labrador Hydro - 2017 General Rate Application - Filing Schedule for Updates**


In correspondence of September 14, 2018 Hydro advised that it would file, on September 18, 2018, an update to provide a revised forecast of off-island purchases for 2018 and 2019 and the revised 2017 General Rate Application customer rate projections for 2019 reflecting the revised monopole commissioning date. This information has not yet been filed by Hydro. The Board further notes that Hydro is required to file an updated fuel price forecast by the 10<sup>th</sup> working day of October.

The Board requires that Hydro file, by Friday, October 26, 2018, an update reflecting both the revised forecast of off-island purchases and the updated fuel price forecast along with the revised customer rate projections for 2019 for each customer class. Hydro should also file a revision to its general rate application to update **Part B. Hydro Proposals**.

The Board also expects that, if Hydro intends to seek interim rates for January 1, ~~2019~~, an application for such relief will be filed by the same date.
