Please provide a table listing each of Hydro's upcoming regulatory activities (i.e., 2 this 2017 GRA, the 2019 GRA, the cost of service study, Outage Inquiry, FERC openaccess transmission tariff, etc.) along with a schedule showing the filing date and 3 4 the date when a decision is anticipated. Please include not only regulatory activities 5 in NL, but also other jurisdictions such as FERC, Quebec, and Nova Scotia, in which 6 Hydro would be a participant, either directly or indirectly. 7 8 9 A. Please refer to Table 1 for a list of Hydro's upcoming and ongoing proceedings. 10 Hydro is unable to provide exact timelines for many of the proceedings identified in 11 Table 1 as the Board has not yet set the schedules. However, in general, application 12 processes include the filing of an application, requests for information (if warranted 13 by the parties and the Board), comments by the parties, a reply by Hydro, and a 14 final decision of the Board. More complex applications, such as general rate 15 applications and cost of service reviews, follow a similar but more robust process – 16 the filing of an application, requests for information (potentially several rounds), 17 expert evidence if warranted, possible settlement negotiations, possible public 18 hearing, and written submissions prior to the Board rendering its final decision. 19 20 Table 2 provides a list of reports Hydro files with the Board, and the frequency of 21 their filing. 22 The projected timelines for the 2017 GRA, the Cost of Service Methodology review, 23 24 and the 2019 GRA filing are provided in Hydro's response to NP-NLH-095. The timeline for the conclusion of Phase II of the Outage Inquiry is uncertain. 25

Hydro believes it will require an open access transmission tariff to be in effect at the time when it begins receiving service over the Labrador-Island Link. Hydro anticipates it will be filing an application by the end of the first quarter of 2018.

Hydro does not currently anticipate being a participant in regulatory proceedings in other jurisdictions.
