The MPPA 2 documents are not relevant to the 2018 Utility Customer Interim Rates 3 Application. 4 5 c) As stated above, the disbursement of transmission tariff revenues to the transmission owner that incurs the costs of providing network transmission 6 7 service is in accordance with the principles of the MPPA. The transmission tariff 8 revenues are apportioned based on the proportionate share of the transmission 9 costs incurred by the transmission owners. As Hydro is effectively incurring all 10 the transmission costs reflected in the Network Service rate, Hydro will be 11 reimbursed all its Network Service charges from the Newfoundland and 12 Labrador System Operator (NLSO). Please refer to Hydro's response to LAB-NLH-13 085(a). 14 15 d) Hydro's Test Year assumes the credits to Hydro for payments to the NLSO for 16 Network Service will equal the forecast annual charges to Hydro based on the 17 approved Network Service tariffs (i.e. \$69.1 million in 2018 and \$98.7 million in 18 2019). As stated in Hydro's responses to LAB-NLH-084 and LAB-NLH-085, the 19 schedules in Hydro's test year cost of service studies do not provide the 20 allocation of the Network Service tariff costs by customer class. Therefore, the 21 information requested is not available. 22 23 e) Please refer to Hydro's response to LAB-NLH-87(d).
