Re: Rate Mitigation Options and Impacts Reference - Response to PUB-Nalcor-078 - Revision 1, December 4, 2019

In our letter dated November 20, 2019, we requested an update to PUB-Nalcor-078 to reflect the <u>current</u> forecast for the 2021 average unmitigated domestic electricity rate and provide a reconciliation explaining all differences between the forecast of 22.89 cents/kWh given in September 2018 in the Reference Questions and in the June 2017 Project Update provided in the response to PUB-Nalcor-026.

The response to PUB-Nalcor-078, Revision 1 filed December 4, 2019 reflected a forecast 2021 average unmitigated domestic electricity rate of 21.16 cents/kWh based on the <u>January 2019</u> Nalcor forecast. Please advise whether January 2019 is Nalcor's most current forecast. If it is, advise when an update will be available.
