Q. In the report under Tab 1.5 Seal Cove Hydro Plant G1 Runner Replacement, Appendix A, page A-2, NP mentions "a water power rental rate of \$0.80 per MWh". Please provide a history of this charge, how it applies to NP's hydro facilities, and the relevant legislation relating to the charge.

A. Newfoundland Power is required under the Water Resources Act to obtain a Water Use License for each hydroelectric development that the Company owns and operates. A Water Use License is required for water use and allocation and granting of water rights for water power generation within the Province. The duration of a Water Use License is typically 50 years. Once the License is expired for any hydroelectric development the Company will file an application with the Department of Environment to renew the License for that particular development.

There are two separate costs that are associated with a Water Use License:

1) Application Fee for a Water Use License; and

2) Annual rent for the Water Use License.

The Application Fee for a Water Use License under the Water Resources Act is a onetime fee that is paid when the application for the Water Use License is submitted to the Department of Environment. This fee is dependent upon the capacity of the hydroelectric development.¹

In addition to the application fee for the Water Use License, the Company is also required each year to pay a water power rental rate of \$0.80 per MWh of power that the Company generates. This rate is set out in Paragraph 4.1 of the Newfoundland and Labrador Regulation 64/03, the *Water Power Rental Regulations 2003* under the *Water Resources Act*.
