1 2 3	Q.	Reference Evidence of Newfoundland power, pages 3 & 21: If we are to look at the "extra" ROE allowed following the financial crisis, why would the correct reference point be a "de novo" ROE award rather than that from the ROE formula which
4		was under examination in the GRA?

6	A.	The Evidence of Newfoundland Power makes no reference to "extra" ROE" as
7		described in this question.
8		
9		In Order No. P.U. 25 (2011), the Board suspended the operation of the Formula for 2012.

This implies that the correct "reference point" for establishing a just and reasonable

return for Newfoundland Power would not be the suspended Formula.
