25		resulting fron	n "M", the Cost of Service rate, being too high when it was last set in	
26		2007. The Co	ost of Service rate in 2007 included Holyrood fuel costs to supply	
27		significant isla	and industrial pulp and paper production which subsequently shut

1 down. In hindsight, Newfoundland Power customers' rates were too high, hence, 2 Rural Customers' rates, whose rates are based on NP customers' rates, were also 3 too high. 4 The refund of the Newfoundland Power RSP Surplus to Rural Customers is in 5 6 keeping with the rural rates policies approved by the Board most recently in Order 7 No. P.U. 14(2007) and reflected in Section 16 of Hydro's Rules and Regulations. 8 "The Policies for Automatic Rate Changes", with respect to Rural Customers on the 9 Island Interconnected and L'Anse au Loup systems, states as follows: "As 10 Newfoundland Power changes its rates, Hydro will automatically adjust all rates such that these customers pay the same rates as Newfoundland Power customers." 11 12 13 With regard to Isolated Systems Customers, it becomes clearer that Government's 14 intention on rates policies is with respect to the effective rate that Rural Customers 15 pay. Rate changes for electricity consumption above the Lifeline Block is described 16 as follows: "Rates charged for consumption above this block will be automatically 17 adjusted by the average rate of change granted Newfoundland Power from time to 18 time" (emphasis added). 19 20 In keeping with the Board approved policy with regard to rural rates for Island 21 Interconnected, L'Anse au Loup and Isolated Customers, it is Hydro's view that 22 effective rates for Rural Customers should be reduced to reflect the lower than 23 anticipated costs of Holyrood fuel which have been reflected in rural rates since 2007. 24
