**Re: Newfoundland and Labrador Hydro - 2013 Amended General Rate Application

The deadline for filing responses to the 2<sup>nd</sup> round of requests for information (RFIs) was due on Wednesday, May 6, 2015. The Board notes that Hydro has yet to respond to 29 of these requests for information and has not provided a reason for the delay in providing these responses. Hydro has advised via email to the Board that the responses are expected to be filed early to mid-next week. The Board encourages Hydro to provide timely and complete responses to keep the schedule on track.


Additionally, in certain responses such as RFIs IN-NLH-312, IN-NLH-314, IN-NLH-315 and IN-NLH-316 Hydro provided the following response:

*Providing an answer to this Request for Information requires Hydro to research and peruse a very large number of documents going back over a decade, therefore, a response cannot be provided with the timeframe allocated in this proceeding to provide responses arising from Hydro's Amended Application. Hydro will provide a response to this Request for Information in due course.*

Hydro has not answered these RFIs but instead has provided reasons why they could not answer these requests by May 6, 2015. The Board therefore requests that the status report provided on May 6, 2015 be revised to indicate that these RFI responses and any other similar responses have not actually been answered. Hydro is also requested to advise when it anticipates filing the responses to these requests for information.
