8		Services (PETS) positions hired over the period 2007 to 2013, transferred or		
9		eliminated that result in the 17.3 FTEs referred to on page 2.33, lines $16-17$ of the		
10		evidence. The net change has been an increase of 15.4 FTEs in PETS regulated		
11		Hydro Operations (combined total for both permanent and temporary). The total		
12		charges in and out further resulted in an additional 1.9 FTEs, which are reflected in		
13		the 17.3 FTEs reported in the evidence.		
14				
15		The net increase in FTEs is attributable to a growing capital program, driven by the		
16		need to sustain and renew aging assets, as well as provide new assets to meet		
17		customer growth. Some existing positions were transferred out of Hydro during the		
18		period in question to better align resources with the areas they primarily work.		
19		Any provision of shared service is allocated to other lines of business as per the		
20		Intercompany Transaction Costing Guidelines referenced in Exhibit 8.
