
The Board is requesting that Hydro provide a further update to the Board on the project to install 100 MW (Nominal) of Combustion Turbine Generation including:

- v) updated risk analysis;
- vi) a list and schedule of contracts; and
- iv) updated project costs.

This information should be filed with the Board no later than Friday, August 15, 2014 and updated thereafter on a bi-weekly basis. The Board may request additional details in future updates.
