I am not sure if you are aware but back in February of this past year we had noticed gassing in T1 at Voisey Bay Nickel Terminal Station. ABB was consulted and later was contracted to complete follow up testing and from this testing there was a recommendation for an internal inspection at a cost of 190 k. This unit is an ABB , Serial Number LL09796-01, 230/13.8 kV, 75/100/125 MVA transformer manufactured in 2011 (Mfg in St. Louis) , but has seen very light loading, as the processing facility has not come up on load yet.

We have to prepare a budget proposal to our Public Utility Board (PUB) requesting funds to complete the internal inspection and probable repairs.

This submission is planned to be completed by the middle of this week and we would like ABB's position on Warranty associated with this unit. We would like to have this question answered, as we are sure this will come back to us from the PUB and we would like to know ABB's position prior to
