All of the amounts received except for the last one pertain to service 15 extensions and distribution upgrading. Service extensions and distribution 16 upgrading projects would result in costs primarily allocated between poles (P07), transformers (T07), street lights (S14) and pole hardware (P04). 17 18 19 The final entry pertains to the relocation of TL-227 and TL-263 in Daniel's Harbour 20 resulting in \$335,301 credited to pole structures – wood (P05) and \$111,767 21 credited to conductor – transmission (C13).
