

1 Reference: On page 8, Ms. Lee states "... it appears as though Hydro
2 calculates the annuity portion of the formula correctly but has not been
3 adding the interest on the reserve for the total monthly or annual
4 depreciation expense."

5 In response to CA-NLH-251, Hydro provided the formula and the detailed
6 depreciation calculation for the CAT Arm Dam 4 asset which shows this
7 100 year asset is fully depreciated in the period 1200 when accumulated
8 depreciation reaches \$14,504,952,42. (An Excel spreadsheet has
9 subsequently been provided.) Interest costs related to funding this asset
10 form a separate component of the revenue requirement.

11 NLH-IC-16 Please provide a similar detailed depreciation calculation for the CAT Arm
12 Dam 4 asset using the method advocated by Ms. Lee and the basis that
13 these calculations would have been applicable in this jurisdiction rather
14 than those that were used. Please provide the related Excel spreadsheet
15 with all formulas intact.

16 RESPONSE: Ms. Lee has reviewed the Excel spreadsheet provided with Hydro's October 15,
17 2012 RFIs. Ms. Lee agrees that the Company's calculations assuming the stated
18 compounded annual interest rate. However, a compounded monthly interest rate
19 rather than a simple monthly interest rate should have been used since the
20 calculation is on a monthly basis. See the attached Excel spreadsheet. Also,
21 Ms. Lee still has concerns with the Company's practice of not changing the
22 interest rate to reflect lower rates or the weighted average cost of capital as
23 noted on pages 9-10 of her testimony. Ms. Lee does not have the required

1 information to recalculate the sinking fund depreciation to recognize changed
2 interest rates.
