**Re: Newfoundland and Labrador Hydro Application for approval of a capital project to supply and install 100 MW of combustion turbine generation – Process**


In relation to your letter of September 22, 2014 the Board advises that as an intervenor in this proceeding you are required to maintain the confidentiality of redacted information unless the Board orders otherwise.

Hydro redacted portions of the information in its response to GT-DD-NLH-001, explaining that certain information is considered by its supplier to be commercially sensitive. Hydro provided the redacted information to the Intervenors on the basis that "Intervenors kindly avoid reproducing or providing these RFI responses to members of the general public."

If you believe the redacted information should be released you can file a motion with the Board for its release. The motion can be in the form of a letter identifying the information that you believe should be released and providing your supporting argument or evidence. Following receipt of your motion the Board will allow an opportunity for the other parties to comment before making a determination in relation to the release of the information. Until the Board orders the release of the information you are expected to respect Board practice and keep it confidential.
