Re: Order No. P.U. 16(2014) - Newfoundland and Labrador Hydro's application to supply and install 100 MW (nominal) of combustion turbine generation - Project update request

In Order No. P.U. 16(2014) the Board stated that it would provide further direction, by way of correspondence to Hydro, on its requirements for project updates.

At this time the Board is requesting that Hydro provide an update to the Board on the following:

- i) Status of tender award, including date of award and successful bidder;
- ii) Project description (based on tender award);
- iii) Project execution team details, including internal resources and external consultants;
- iv) Forecast project costs (based on tender award); and
- v) Project schedule up to December, 2014, showing major milestones for both the procurement, delivery and installation of the combustion turbine as well as the required site work at the Holyrood Thermal Generating Station.

This information should be filed no later than June 9, 2014. The Board will provide further direction on requirements for ongoing reporting on project status following receipt and review of the above information.
