**ORDER**

1 **WHEREAS** Newfoundland Power Inc. (“NP”), filed an application with the Board of  
2 Commissioners of Public Utilities (“the Board”) on May 10, 2007 for approval of, among other  
3 things, proposed rates for the various customers of NP, effective January 1, 2008 (the  
4 “Application”); and

6 **WHEREAS** Notice of the Application and Pre-hearing Conference was published in newspapers  
7 throughout Newfoundland and Labrador beginning on May 19, 2007; and  
8

9 **WHEREAS** on June 12, 2007 a Pre-hearing Conference was held in the Board’s Hearing Room, 2<sup>nd</sup>  
10 Floor, Prince Charles Building, 120 Torbay Road, St. John’s; and  
11

12 **WHEREAS** on June 22, 2007 the Board issued P.U. Order No.17 (2007), among other things,  
13 establishing a schedule of dates for the proceeding including the deadline for the filing of settlement  
14 agreements, issues lists and the date for the start of the hearing of evidence October 16, 2007; and  
15

16 **WHEREAS** on September 20, 2007 the Board appointed facilitator wrote the Board to advise that  
17 the parties were still actively negotiating certain issues and were optimistic that an agreement would  
18 be reached which would be filed on or before October 12, 2007; and  
19

20 **WHEREAS** on October 2, 2007 the Board appointed facilitator wrote the Board to advise that  
21 settlement negotiations continue and requested that the previously established requirement to file  
22 separate issues lists be rescinded and replaced with a requirement to file an issues list as part of the  
23 settlement agreement; and

25 **WHEREAS** the Board has determined that to ensure full and effective consideration of the issues in  
26 the proceeding the parties may file an issues list as part of a settlement agreement on or before  
27 October 12, 2007 and further that the hearing of the evidence will begin on October 22, 2007.
