

## Re: Compliance Item with Board Order P.U. 19 (2003) A Report on the Stand-Alone Credit of Newfoundland Power

On June 30, 2004 Newfoundland Power filed a report (the "Report") on its stand-alone credit status with the Board. In the Report, Newfoundland Power indicated that it was continuing its assessment in relation to its stand-alone credit status and that it expected a final report to be completed by year-end. In its September 28, 2004 letter to Newfoundland Power, the Board requested that the results of this review and the steps that Newfoundland Power intends to take to ensure its stand-alone credit status be filed with the Board by January 15, 2005.

One of the issues identified in the Report was the possible establishment by Newfoundland Power of committed credit arrangements. The Company expects to conclude such arrangements in the next week or so, however, the establishment of committed credit arrangements did take the Company longer than was expected at the time of filing the Report. This, in turn, has delayed the Company's completion of the steps necessary to ensure the maintenance of its stand-alone financial integrity beyond the end of 2004 as envisaged in the Report.

The Company now expects to complete the necessary steps to ensure maintenance of its stand-alone financial integrity by the end of the 1<sup>st</sup> Quarter of 2005. Accordingly it expects to be in a position to file a further report on this matter by April 15, 2005.


