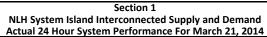
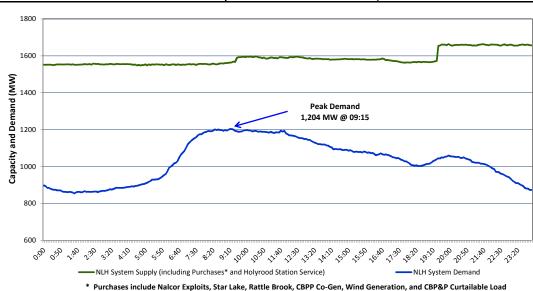
Newfoundland Labrador Hydro (NLH) Supply and Demand Status Report Filed March 24, 2014





Supply Notes for March 21, 2014

- As of 0422 hours, Feb. 17, 2014, Bay d'Espoir Unit 6 (77 MW) unavailable for service.
- → As of 0627 hours, March 17, 2014, Holyrood Unit 1 derated to 150 MW from 170 MW.
- As of 0930 hours, Hardwoods End B (25 MW) available for service. Full capacity available (50 MW).
- → As of 1916 hours, Bay d'Espoir Unit 4 (77 MW) available for service.

Supply Notes for March 22, 2014³

→ Notes:

- Generation outages for running and corrective maintenance are included. These are not unusual for power system operations. They generally do not impact
 customer supply. The power system operators schedule outages to system equipment whenever possible to coincide with periods when customer demands
 are low and sufficient supply reserves are available. However, from time to time equipment outages are necessary and reserves may be impacted.
- 2. Due to the Island Interconnected System being isolated from the larger North American grid, when there is a sudden loss of large generating units some customer's load must be interrupted for short periods to bring generation output equal to customer demand. This automatic action of power system protection, referred to as underfrequency load shedding, is necessary to ensure the integrity and reliability of system equipment. Underfrequency events typically occur 5 to 8 times per year on the Island Interconnected System and the resultant customer load interruptions are generally less than 30 minutes.
- 3. As of 0800 Hours.
- 4. Gross output including station service at Holyrood (24.5 MW) and improved hydraulic output due to water levels (35 MW). Includes Nalcor Exploits, Star Lake, Rattle Brook, CBPP Co-Gen, and CBPP Curtailable Load (60 MW). Excludes wind generation.
