

Newfoundland Labrador Hydro (NLH) Supply and Demand Status Report Filed Thursday, September 10, 2015





Supply Notes For September 09, 2015

- A As of 1440 hours, June 06, 2015, Holyrood Unit 2 removed from service for annual maintenance (170 MW).
- B As of 1450 hours, June 24, 2015, Hawke's Bay Unit 548 (G2) unavailable (2.5 MW).
- As of 1602 hours, July 31, 2015, Hardwoods Gas Turbine derated to 38 MW (50 MW). End A 20 MW, End B 19 MW.
- D As of 0949 hours, August 01, 2015, Holyrood Unit 1 removed from service for annual maintenance (170 MW).
- E As of 1330 hours, August 19, 2015, Bay d'Espoir Unit 2 unavailable (76.5 MW).
- F As of 1042 hours, August 31, 2015, Stephenville Gas Turbine unavailable. Previously derated to 30 MW (50 MW).
- G As of 1510 hours, September 02, 2015, Bay d'Espoir Unit 1 available. Derated to 45 MW (76.5 MW).
- H As of 1525 hours, September 07, 2015, Star Lake Unit unavailable. Previously derated to 12 MW (18 MW).
- As of 0808 hours, September 08, 2015, Cat Arm Unit 2 unavailable (67 MW).
- J As of 2340 hours, September 08, 2015, Holyrood Unit 3 unavailable. Previously derated to 70 MW (150 MW).

Supply Notes For September 10, 2015

- Notes: 1. Generation outages for running and corrective maintenance are included. These are not unusual for power system operations. They generally do not impact customer supply. The power system operators schedule outages to system equipment whenever possible to coincide with periods when customer demands are low and sufficient supply reserves are available. However, from time to time equipment outages are necessary and reserves may be impacted.
 - 2. Due to the Island Interconnected System being isolated from the larger North American grid, when there is a sudden loss of large generating units some customer's load must be interrupted for short periods to bring generation output equal to customer demand. This automatic action of power system protection, referred to as underfrequency load shedding, is necessary to ensure the integrity and reliability of system equipment. Underfrequency events typically occur 5 to 8 times per year on the Island Interconnected System and the resultant customer load interruptions are generally less than 30 minutes.

 - 4. Gross output including station service at Holyrood (24.5 MW) and improved NLH hydraulic output due to water levels (35 MW).
