

Supply Notes For October 03, 2018

- A As of 1000 hours, July 27, 2018, Holyrood Unit 1 unavailable due to planned outage 88 MW (170 MW).
- B As of 1118 hours, August 21, 2018, Holyrood Gas Turbine unavailable due to planned outage (123.5 MW).
- C As of 1034 hours, September 17, 2018, Bay d'Espoir Unit 4 unavailable due to planned outage (76.5 MW).
- D As of 2004 hours, September 22, 2018, Bay d'Espoir Unit 3 unavailable due to planned outage (76.5 MW).
- E As of 1623 hours, September 28, 2018, Holyrood Unit 3 unavailable due to planned outage 110 MW (150 MW).
- F At 0819 hours, October 03, 2018, Stephenville Gas Turbine unavailable due to planned outage 25 MW (50 MW).
- G At 1116 hours, October 03, 2018, Hardwoods Gas Turbine unavailable (50 MW).
- H At 1126 hours, October 03, 2018, Hardwoods Gas Turbine available (50 MW).
- I At 1735 hours, October 03, 2018, Stephenville Gas Turbine available at 25 MW (50 MW).

Supply Notes For October 04, 2018

- J At 0700 hours, October 04, 2018, Stephenville Gas Turbine unavailable due to planned outage 25 MW (50 MW).

- Notes:
1. Generation outages for running and corrective maintenance are included. These are not unusual for power system operations. They generally do not impact customer supply. The power system operators schedule outages to system equipment whenever possible to coincide with periods when customer demands are low and sufficient supply reserves are available. However, from time to time equipment outages are necessary and reserves may be impacted.
 2. Due to the Island System having no synchronous connections to the larger North American grid, when there is a sudden loss of large generating units some customer's load must be interrupted for short periods to bring generation output equal to customer demand. This automatic action of power system protection, referred to as under frequency load shedding, is necessary to ensure the integrity and reliability of system equipment. Under frequency events typically occur 5 to 8 times per year on the Island Interconnected System and the resultant customer load interruptions are generally less than 30 minutes.
 3. As of 0800 Hours.
 4. Gross output including station service at Holyrood (24.5 MW) and improved NLH hydraulic output due to water levels (35 MW).
 5. Gross output from all Island sources (including Note 4).
 6. NLH Island Power Purchases include: CBPP Co-Gen, Nalcor Exploits, Rattle Brook, Star Lake, Wind Generation and capacity assistance (when applicable).
 7. Adjusted for curtailable load, market activities and the impact of voltage reduction when applicable.
