

Island Supply Notes For May 28, 2025

- A As of 0800 hours, March 30, 2025, Holyrood Unit 3 unavailable due to planned outage 130 MW (150 MW).
- B As of 0823 hours, March 31, 2025, Bay d'Espoir Unit 1 unavailable due to planned outage (76.5 MW).
- As of 0823 hours, March 31, 2025, Bay d'Espoir Unit 2 unavailable due to planned outage (76.5 MW).
- D As of 1543 hours, May 03, 2025, Holyrood Unit 2 available but not operating 115 MW (170 MW).
- As of 0800 hours, May 04, 2025, Holyrood Unit 1 unavailable due to planned outage (170 MW).
- As of 0851 hours, May 05, 2025, Hardwoods Gas Turbine unavailable due to planned outage (50 MW).
 - As of 1538 hours, May 16, 2025, Holyrood Diesels available at 8 MW due to forced derating (10 MW).
- As of 1527 hours, May 26, 2025, St. Anthony Diesel Plant available at 7.85 MW due to forced derating (9.7 MW).

Island Supply Notes For May 29, 2025

otes: 1. Generation outages for running and corrective maintenance are included. These are not unusual for power system operations. They generally do not impact customer supply. Hydro schedules outages to system equipment whenever possible to coincide with periods when customer demands are low and sufficient supply reserves are available. However, from time to time equipment outages are necessary and reserves may be impacted.

- 5. NLH Island Power Purchases include: ML Imports, Exploits Generation, Rattle Brook, Star Lake, Wind Generation and capacity assistance (when applicable).

- 7. Due to limitations inherent in the design of combustion turbines, the output of combustion turbines may be reduced in the event that ambient temperatures exceed the threshold required for full rated output. This threshold is dependent on the design of each turbine.

- 9. LIL Import sunk in the Island System. Actual LIL flows will be restricted by various system conditions including, but not limited to, Island Load, ML Exports and Avalon Unit status.
