Re: The Board's Investigation and Hearing into Supply Issues and Power Outages on the Island Interconnected System - Request to resubmit information requests filed after August 26, 2014

This is further to your letters of August 26, September 28 and October 3, 2014 with respect to the Requests for Information submitted by Grand RiverKeeper Labrador, Inc. (GRK) in this matter.

On July 2, GRK submitted RFIs GRK-NLH-01 to GRK- NLH-52. On September 28 GRK submitted a second round of RFIs, GRK-NLH-54 to 70 and GRK-NLH-71 to 91, which were stated to be subject to the Board's decision on Hydro's Motion of July 7, 2014. On September 29, the Board responded by email advising that these RFIs were incorrectly labelled as they had started with RFI number GRK-NLH-54 instead of GRK-NLH-53 as the last RFI received from the GRK was RFI GRK-NLH-52, thereby skipping over RFI number GRK-NLH-53. When the GRK resubmitted its RFIs on September 30 it included GRK-NLH-53 as well. The correspondence from the Board on September 29, inadvertently neglected to reference RFIs GRK-NLH-53 to 57 which were added to the GRK's submission of August 26, 2014.

On October 16, 2014 the Board issued Order No P.U. 41(2014) with respect to a Notice of Motion by Newfoundland and Labrador Hydro for a "*determination that certain Requests for Information filed by Mr. Danny Dumaresque and Grand RiverKeeper Labrador, Inc. were not relevant in the matter of an investigation and hearing into supply issues and power outages on the Island Interconnected system.*" The Board's order dealt with RFI numbers from GRK-NLH-01 to GRK-NLH-57 which were submitted up to and including to August 26, 2014.

In light of the Board's Order and to clarify the file record, the Board is requesting that the Grand Riverkeeper, Inc. resubmit its second round of RFIs which were submitted after August 26, 2014 and start them with the RFI Number GRK-NLH-58.
