
Re: Newfoundland and Labrador Hydro - the Board's Investigation and Hearing into Supply Issues and Power Outages on the Island Interconnected System – Outstanding Request for Information (RFI) Responses

On June 13, 2014 the Board set July 25 as the deadline for filing of responses to requests for information in this matter. On July 25 Hydro filed a number of the outstanding responses. In its cover letter Hydro stated that *"We anticipate that the remaining Requests for Information will be filed in the coming week"*. No date was provided for the filing of the responses.

Hydro has yet to respond to approximately 30 of 114 outstanding requests for information which were due on July 25th, aside from the 96 it has refused to answer which are the subject of a motion. Hydro did not provide the date when the responses to the outstanding requests for information will be filed. To move this matter forward, the Board asks Hydro to advise immediately when it anticipates filing the outstanding responses.

The Board notes that Hydro requested extensions to filing deadlines in this matter on February 12, March 18 and June 16. In these instances, the filing dates were extended to February 17, March 26, and June 27. In addition Hydro filed responses beyond the established deadlines on four occasions. The orderly and efficient progress of this matter requires that all involved observe the schedule that is set. The Board looks forward to Hydro focusing its efforts to meet the established deadlines as this matter progresses.
