**Re: The Board's Investigation and Hearing into Supply Issues and Power Outages on the Island Interconnected System – Phase One – Submissions due February 5, 2015**

We write further to the counsel meeting of January 7, 2015 and correspondence from the Industrial Customers of January 12, 2015 regarding the submissions to be filed by Hydro and Newfoundland Power on February 5, 2015.
