Re: The Board's Investigation and Hearing into Supply Issues and Power Outages on the Island Interconnected System - Clarification of Hearing Schedule

The Board's schedule for this proceeding was established in Order No. P.U. 3(2014). The first part of this hearing was compressed to allow the Board to deal with the more urgent issues in a timely manner. The Board will issue an interim report on these issues on May 15, 2014, following which the Board will schedule the remainder of the hearing process. This process will include a schedule and timeline for issuing and answering requests for information (RFI's), filing of written and oral evidence, public hearing days, public presentations and written and oral submissions.

The Board received has now received 2 sets of RFIs from intervenor Mr. Danny Dumaresque. As the schedule for the RFI process, including filing deadlines, has not yet been set, responses to the RFIs are not required until the Board sets the remaining schedule for the hearing process.

For clarification any party may submit RFI's at any time during this proceeding; however, responses are not required and may not be answered until the response filing deadlines are established by the Board.
