No capital 3 4 costs relating to CDM for Island customers, are currently, or will in the future, be included in rate base. 5 b) CDM costs for Labrador customers will be recovered in the ECDM Deferral Account. No 6 7 capital costs relating to CDM for Labrador customers are currently, or will in the future, be included in rate base. 8 c) Electrification costs, ignoring capital for charging stations, for Island customers will be 9 recovered in the ECDM deferral account. 10 d) Electrification costs, ignoring capital for charging stations, for Labrador customers will be 11 12 recovered in the ECDM deferral account. e) Capital costs for charging stations on the Island, less Government funding, will be recovered 13 14 in the ECDM Deferral Account and will not be included in rate base. f) Capital costs for charging stations in Labrador, less Government funding, will not at this time 15 be recovered from customers, and will not be included in rate base, but may be recovered 16 17 from customers in the future in the ECDM deferral account if it is determined that they are beneficial to customers and are consistent with the provision of least cost reliable service. 18 19 20 21 a) Electrification, Conservation and Demand Management ("ECDM") costs, as well as capital Α. 22 expenditures related to public charging stations on the Island Interconnected System are proposed to be charged to the ECDM Cost Deferral Account and recovered through the 23 ECDM Cost Recovery Adjustment.<sup>1</sup> As the costs of these assets are proposed to be charged 24

- to the ECDM Cost Deferral Account, they will be excluded from Newfoundland and Labrador
  Hydro's ("Hydro") capital assets. Hydro's deferral accounts are included in its computation
  of rate base.
- b) It is confirmed that Conservation and Demand Management ("CDM") costs for Labrador 4 customers will be charged to the ECDM Cost Deferral Account and recovered through the 5 6 ECDM Cost Recovery Adjustment as detailed in that proposed adjustment.<sup>2</sup> The capital expenditures related to the fast charging stations located in Labrador will not be included in 7 rate base, nor will they be charged to the ECDM Cost Deferral Account or recovered through 8 the ECDM Cost Recovery Adjustment. As noted in Hydro's application,<sup>3</sup> if future evaluation 9 determines that costs associated with electrification in Labrador are beneficial to customers 10 11 and consistent with the provision of least-cost, reliable service over the long term, Hydro may propose to include prospective costs associated with the Labrador Interconnected 12 System chargers in its ECDM Cost Deferral Account at that time. 13

- 15d) Only those program costs pertaining to CDM on the Labrador Interconnected System,16including costs associated with electric vehicle charging stations that are capable of demand17response, will be charged to the ECDM Cost Deferral Account and for future recovery from18customers. As noted in Hydro's response to CA-NLH-002, part b, no capital expenditures19related to the Labrador fast charging stations are proposed to be charged to the ECDM Cost20Deferral Account.
