Re: Newfoundland and Labrador Hydro - 2024 Capital Budget Supplemental Application - Approval of Capital Expenditures for Replacement of Rigolet Unit 2065 and Fuel Storage Upgrades – To Nunatsiavut Government – Opportunity to Participate

On August 9, 2024, the Board received an application from Newfoundland and Labrador Hydro ("Hydro") for approval of capital expenditures for the replacement of Rigolet Unit 2065 and fuel storage upgrades (the "Application"). The project is expected to take three years, and has an estimated cost of \$3,429,200. A copy of the Application can be found on the Board's website and is attached herein.
