Re: Newfoundland and Labrador Hydro - Application for July 1, 2025 Utility Rate Adjustments To NP - Request to Provide Supporting Information


On April 15, 2025, Newfoundland and Labrador Hydro (“Hydro”) filed its application with the Board seeking approval for the July 1, 2025 Utility Rate Adjustments (“Application”). In the cover letter of the Application, Hydro noted that they had collaborated with Newfoundland Power Inc. (“Newfoundland Power”) to limit the rate increase associated with Hydro’s costs to 2.25% for Island Interconnected Domestic customers for July 1, 2025, in compliance with Order in Council OC2024-062.

In particular, on page 4, paragraph 20 of the Application, it is stated that Hydro, in consultation with Newfoundland Power, calculated the Project Cost Recovery Rider using detailed calculations performed by Newfoundland Power to meet the targeted domestic rate increase, as provided in Schedule 2 of the Application.

The Board is requesting Newfoundland Power to provide the supporting information/calculations for Schedule 2, page 1 of 2 of the Application. Upon receipt of this information, the Board will set a Review Schedule for this Application.
