Re: Newfoundland and Labrador Hydro - 2026 Capital Budget Application -Confidential Information

On July 15, 2025 Hydro filed its 2026 Capital Budget Application with the Board. On page 2, Hydro stated:

Appendix A to this schedule contains specifics pertaining to individual projects expenditures and is commercially sensitive information.

The Board's general policy is that all information filed with the Board should be available for the parties and the public to review to ensure that proceedings are open, transparent and accessible. The Board acknowledges that some information may be of a confidential nature. To assist that Board in making its determination of whether the information is confidential and should be protected, the Board requires Hydro to identify each piece of information filed as confidential, the basis for the claim and why public disclosure would be detrimental.

The Board also requires Hydro to file a Five-Year Capital Plan that incorporates both major capital and non-major capital projects in a single report.
