Midgard chose utilities of different sizes for its analysis but excluded those that are

very small (i.e., much smaller than the two Newfoundland and Labrador utilities). Specifically, certain municipal utilities such as E.L.K. Energy Inc. were considered

too small for inclusion in Midgard's jurisdictional review because the asset

management strategies they employed were not scalable to Newfoundland and

Labrador's larger utility size. For example, E.L.K's strategy is for its staff to "know" each pole because there are only 89km of distribution circuits and associated

distribution poles in their jurisdiction¹ compared to Newfoundland Hydro's

approximate 70,000 km² service territory² and associated distribution; a number of
