A. Please see Attachment A, which lists the issue ratings from S&P and Moody's for the holding companies in both proxy groups. Concentric notes that its screening criteria for selecting the proxy group uses long-term issuer ratings, not issue ratings. The operating subsidiaries of these companies typically have their own credit ratings and issue debt at the subsidiary level.
