Discontinue the Requirement to File Labrador Island Link Quarterly Update Reports**

The Board has discontinued the requirement for Newfoundland and Labrador Hydro ("Hydro") to file Labrador Island Link ("LIL") Quarterly Update reports.

Since commissioning, Hydro has integrated LIL reporting into its regulatory reports including the Daily Supply and Demand, Winter Readiness and its Quarterly Report on Asset Performance in Support of Resource Adequacy. Information on asset performance and capital projects regarding the LIL will continue to be filed with the Board in these reports moving forward.
