**Re: Quarterly Update – Items Impacting the Delay of Hydro's Next General Rate Application**

In Order No. P.U. 15(2020),<sup>1</sup> the Board of Commissioners of Public Utilities ("Board") approved Newfoundland and Labrador Hydro's ("Hydro") request to delay the filing of its next general rate application ("GRA").<sup>2,3</sup> The Board directed Hydro to file quarterly updates with respect to the filing of its next GRA beginning on September 30, 2020 and to include the following:

**(i) Information related to:**

- a. The time frame for the commissioning of the Muskrat Falls Project ("Project");
- b. The financial restructuring of the Muskrat Falls Power Purchase Agreement ("Muskrat Falls PPA");
- c. The completion of the Government of Newfoundland and Labrador's ("Government") rate mitigation plan; and

**(ii) Projected 2021 cost increases and Hydro's plans to address these increases.**

**Muskrat Falls Project Schedule**

As part of its ongoing *Reliability and Resource Adequacy Study Review* proceeding, Hydro continues to provide monthly updates on the status of the Labrador-Island Link ("LIL") and the Muskrat Falls Hydroelectric Generating Facility, as well as other relevant operational and commercial information.<sup>4</sup> The update provided herein reflects the information that was available as of the date of this correspondence.

### **Muskrat Falls Hydroelectric Generating Facility**

Unit 4, the final of four units at the Muskrat Falls Hydroelectric Generating Facility, was released for service on November 22, 2021 and accepted into commercial operation. As such, the Muskrat Falls Hydroelectric Generating Facility is considered commissioned pursuant to the commercial and financial agreements.<sup>5</sup>

### **Labrador-Island Link**

On April 14, 2023, the Independent Engineer issued a Confirmation of Commissioning Certificate and the lender's representative issued a Commissioning Confirmation acknowledging that all of the conditions required for commissioning of the LIL pursuant to the project financing agreement were achieved, and that commissioning had occurred on April 14, 2023. As such, the LIL is officially commissioned in accordance with the project financing and revenue agreements.<sup>6</sup>

### **Financial Restructuring of the Project Agreements and Government's Rate Mitigation Plan**

The finalization of the \$1 billion federal loan guarantee, the \$1 billion investment by Canada in the province's portion of the LIL, and capital restructuring for the Project agreements was announced by Hydro on March 31, 2022.<sup>7</sup>

With the commissioning of the LIL, Hydro is continuing to meet with Government on an ongoing basis regarding the development and finalization of the rate mitigation plan. The outstanding actions related to the finalization of the details of the rate mitigation plan include confirmation of the mechanism by which rate mitigation will be provided to customers and confirmation of the amount and timing of the provision of rate mitigation funding.

### **Projected Supply Increases**

The approved Supply Cost Variance Deferral Account was put in place to address the cost impact of the contractual requirements related to the Project<sup>8</sup> and was effective as of November 1, 2021.<sup>9</sup> Hydro commenced recovery of Project costs and implemented a Project Cost Recovery Rider effective July 1, 2022.<sup>10</sup> The Board approved the continuation of the Project Cost Recovery Rider within Hydro's 2023 Utility Rates Adjustment application.<sup>11,12</sup>

### **Proposed Timing of Hydro's Next GRA**

Contingent on the finalization of the details of the Government's rate mitigation plan, Hydro expects the earliest timeframe for filing its next GRA to be mid-2024.

Hydro continues to estimate that it would require approximately nine months to prepare its next GRA. With the commissioning of the LIL complete, this timeline would begin once Hydro has certainty related

to the details of the Government's rate mitigation plan, as without having the required information, Hydro does not have adequate certainty to develop a test year forecast revenue requirement for use in its GRA filing. Hydro is cognizant of the regulatory inefficiencies that would result if its GRA proposals are not reflective of the final rate mitigation plan.

Hydro will continue to provide quarterly updates to the Board on the timing of its next GRA and will confirm a more defined timeframe for the filing of its GRA when further information is available.
