

**P.U. 38(2004)**

**IN THE MATTER OF** the  
*Public Utilities Act*,  
R.S.N. 1990, c. P-47, as amended  
(the “*Act*”)

**AND**

**IN THE MATTER OF** the application by  
Newfoundland Power Inc. (the “Applicant”)  
for approval of a contribution in aid of  
construction (“CIAC”) for a line extension to  
serve a seasonal customer, Mr. Oscar Heaney,  
(the “Customer”) pursuant to section 41(5)  
of the *Act*.

**WHEREAS** the Applicant is a corporation duly organized and existing under the laws of  
the Province of Newfoundland and Labrador, is a public utility within the meaning of the Act, and is  
also subject to the provisions of the *Electrical Power Control Act, 1994*; and

**WHEREAS** the Customer is a single Seasonal Customer whose seasonal residence is located  
near the community of Port Blandford; and

**WHEREAS** the Customer has requested that the Applicant provide his residence near Port  
Blandford with single-phase electrical service which, in order to so provide, requires the  
construction of a single-phase extension of 184 metres (the “Extension”); and

**WHEREAS** the Extension will not be jointly used by the Applicant and Aliant Telecom Inc.; and

**WHEREAS** a CIAC has been calculated in accordance with Clause 5(b) of the CIAC Policy: Distribution Line Extensions to Residential and Seasonal Residential Customers approved by Order No. P.U. 7 (1997-98) dated September 30, 1997 (the “Policy”) and the CIAC thus calculated is Six thousand five hundred ninety-four dollars and ten cents (\$6,594.10), including HST; and

**WHEREAS** Clause 12 (c) of the Policy states that all CIACs for Main Line extensions for primarily seasonal residential customers be submitted to the Board for approval; and

**WHEREAS** the proposed CIAC is necessary to ensure that the Applicant’s investment in the Extension is compensatory over the useful life of the Extension and will not be to the detriment of the Applicant’s other customers.

**IT IS THEREFORE ORDERED THAT:**

Pursuant to Section 41(5) of the Act, the Board approves the CIAC in the amount of Six thousand five hundred ninety-four dollars and ten cents (\$6,594.10), including HST, as calculated under the Policy to provide single-phase electrical service to Mr. Oscar Heaney of Port Blandford.
