AN ORDER OF THE BOARD

1 **IN THE MATTER OF** the *Petroleum*
2 *Products Act*, SNL 2001, Chapter P-10.1
3 (the “*Act*”), and regulations thereunder;

6 **IN THE MATTER OF** the temporary
7 maximum gasoline price to be charged by
8 certain retailers in Zone 11 pursuant to Order
9 Nos. P.P. 11 and 14(2020) and the maximum
10 wholesale prices established in Order No.
11 P.P. 17(2020) to be charged for gasoline,
12 diesel and stove oil in Zones 10, 11 and 12.

15 **WHEREAS** in Order Nos. P.P. 11 and 14(2020) the Board established a temporary maximum
16 price to be charged by two retailers, Gateway Ventures Limited and M&K Cartwright Ltd., for
17 gasoline in Zone 11, on an interim basis until a further order of the Board; and
18

19 **WHEREAS** in Order No. P.P. 17(2020) the Board established the maximum wholesale price to
20 be charged for gasoline, diesel and stove oil in Zone 10 (Labrador – The Straits to Red Bay),
21 Zone 11 (Labrador South - Lodge Bay/Cartwright), Zone 11b (Coastal Labrador South – Drum
22 Delivery) and Zone 12 (Central Labrador), effective April 16, 2020; and

24 **WHEREAS** the maximum retail prices for gasoline, diesel and stove oil in Zones 10, 11, 11b
25 and 12 will increase as a result of the changes to the maximum wholesale prices that were
26 established in Order No. P.P. 17(2020); and

28 **WHEREAS** the Board is satisfied that it is reasonable to discontinue the temporary maximum
29 price for gasoline in Zone 11 which was established in Order No. P.P. 14(2020) to be charged by
30 Gateway Ventures Limited and M&K Cartwright Ltd.

IT IS THEREFORE ORDERED THAT:

33 1. The maximum price established in Order No. P.P. 14(2020) to be charged by Gateway
34 Ventures Limited and M&K Cartwright Ltd., for gasoline in Zone 11 is discontinued.
