20	WHEREAS the Board is satisfied that maximum wholesale and retail prices in Zones 10, 11, 11a,
21	11b, 12 and 14 should be adjusted to reflect the winter supply of gasoline and diesel motor fuels
22	and stove oil heating fuel; and

24	WHEREAS the Board is satisfied that the seasonal suspension of maximum price adjustments
25	should be implemented for gasoline and diesel motor fuels and stove oil heating fuel in Zones 10,
