Newfoundland Power's General Rate Application
Public Utilities Board approves final rates for January 1, 2010

The Board of Commissioners of Public Utilities today issued Order Nos. P.U. 46(2009) and P.U. 47(2009), as well as its Reasons for Decision in connection with Order No. P.U. 43(2009), approving final rates for Newfoundland Power and certain Newfoundland and Labrador Hydro customers. These final rates will take effect January 1, 2010 and reflect an overall average increase of 3.5% in Newfoundland Power's rates.

These Orders conclude the regulatory process that began on May 28, 2009 when Newfoundland Power filed a general rate application proposing an overall average rate increase of 6.1%. Registered intervenors were the Government appointed Consumer Advocate, Mr. Thomas Johnson, and Newfoundland and Labrador Hydro. On September 28, 2009, following a Board facilitated negotiated settlement process, Newfoundland Power amended its application to reflect updated forecasts and changes arising from a settlement agreement and intervening Board orders, including the annual July 1st rate adjustment to reflect variances in the cost of fuel at the Holyrood Thermal Generating Station. The amended application proposed an overall average increase of 7.2% in the rates that were established on July 1, 2009.

On December 11, 2009 following a public hearing the Board issued Order No. P.U. 43(2009) directing Newfoundland Power to file revised rates. On December 16, 2009 Newfoundland Power filed an application setting out revised rates in accordance with the Order of the Board. On December 18, 2009 Newfoundland and Labrador Hydro also filed an application for approval of revisions to rates for certain customers since rates for its Island Interconnected customers (excluding Burgeo School and Library) and Isolated Rural Customers (excluding Government departments) are based on Newfoundland Power's rates.

The specific impact of these Orders on electricity customers' bills will vary depending on the class of service and the amount of electricity used. For example, excluding discounts and taxes, a Newfoundland Power residential customer using 1,000 kWh per month will pay \$4.23 or 4.0% more monthly as of January 1, 2010, while a customer using 2,000 kWh per month will see an increase of \$8.46 or 4.4%, compared to existing rates. Additional information on the rates and customer impacts is attached.
